MEMORANDUM OF UNDERSTANDING



1. BACKGROUND

Academic collaborations play vital role in the overall progress of the Higher Education Institutes. It is the need of the time to collaborate with other institutions for variety of academic purposes.

In the view of above a need this Memorandum of Understanding (hereinafter called as the 'MOU') is entered into on this 30th day of June-Two Thousand and Eighteen (30/06/2018), by and between

Sports Department, Shivaji College, Hingoli,

The First Party, represented herein by its Sports Director, (hereinafter referred as 'First Party, the institution which expression, unless excluded by repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

AND

Hingoli District Athletics Association, Hingoli

The Second Party, represented herein by its Secretary, (hereinafter referred as 'Second Party, company which expression, unless excluded by repugnant to the subject or context shall include its successors-in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and (First Party and Second Party are hereinafter individually referred to as 'Party').

WHEREAS:

First Party & Second Party believe that collaborations and co-operation between themselves will promote more effective use of each of their resources, and provided each of them with enhanced opportunities.

The Parties intent to cooperates and focus their efforts on cooperation within area of Sports, Teaching and Learning, Research, Training and Extension Activities.

Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

Now therefore, in consideration of the mutual promises set forth in this MOU, the parties here to agree as follows:

CLAUSE 1: CO-OPERATION

i. Both the parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings.

ii. Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

iii. First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of both the parties providing significant inputs to them in developing suitable teaching/training systems, keeping in mind the needs of both the parties.

CLAUSE 2: SCOPE OF THE MoU

MoU will facilitate the following:

Organizing Athletics competitions

Organizing District Meet for the competition

Organizing camps for the college students

Guiding the students for Athletics

Encouraging the students to participate in University, State and National level competitions

CLAUSE 3: VALIDITY

 This Agreement will be valid for minimum two years and maximum for six years. ii. Both Parties may terminate this MOU upon complementation of one year. They have to give 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
